### **REVIEW OF CONSENT ITEMS**

The September Minutes and Consent Agenda and items were reviewed prior to the meeting. Kent Lammers asked for a motion to approve the consent items and minutes. This motion was made by Ryan O'Reilly and seconded by Fr. Tom Kiefer. The motion was approved.

#### **REPORTS**

#### **Financial Statements:**

- **A.** Lisa Ellis presented September 2025 financial statements, detailing cash equivalents and accounts receivable. She presented financials, showing \$6,376,932 in operating cash and \$7,889,012 in total cash and cash equivalents. Kent Lammers asked for a motion to approve September Financial Statements. - **B.** Enrollment for the 2025-2026 school year is at 1,331 students.
- **C.** MO Scholars was also discussed, showing an increase of students enrolled in the program from 17 in 2024-2025 to 70 in 2025-2026.

#### **Director of Schools:**

Mrs. Jeanne Skahan shared several updates including:

- To help with communication with parents, teachers were asked to shift to email and Google Classroom for teacher-parent communication only.
- Parent/Teacher Conferences will be held for all schools at the end of the October.
- Principals are piloting the behavior rubric this school year and adjusting as necessary in an effort for consistency and transparency.
- The Endowment Committee meets Tuesday, October 14<sup>th</sup>.
